Scope

Website practices

- We use your IP address to help diagnose problems with our server, and to administer our web site.
- Your IP address is used to help identify you and to gather broad demographic information.
- Our site uses cookies. We use cookies to deliver content specific to your interests, to save your password so you don't have to re-enter it each time you visit our site, and for other purposes.
- Our site's contact form requires users to give us contact details. We use customer contact information from the registration form to send the user information about our company. The customer's contact information is also used to contact the visitor when necessary. Users may opt-out of receiving future mailings; see the choice/opt-out section below.

- Our site uses an order form for customers to request information, products, and services. We collect visitor's financial information (like their account or credit card numbers). Financial information that is collected is used to check the users' qualifications and bill the user for products and services.

Security

- Globe2 has security measures in place to protect the loss, misuse and alteration of the information under our control.
- Globe2 uses a specialist gateway system for all transactions. This means that our system doesn't hold sensitive information on our site. Should anyone gain unauthorised access to our database the information they obtain will not allow them to recover credit card details or other sensitive information.
- We do not store customer credit or debit card on local computers or any other form
